



## Parental Involvement Policy

### PART I. GENERAL EXPECTATIONS

**Harding Fine Arts Academy** agrees to implement the following statutory requirements:

- **HARDING FINE ARTS ACADEMY** will put into operation programs, activities and procedures for the involvement of parents, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). Those programs, activities and procedures will be planned and operated with meaningful consultation with parents of participating children.
- **HARDING FINE ARTS ACADEMY** will incorporate this district-wide parental involvement policy into its LEA plan developed under section 1112 of the ESEA.

  - (C) that parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child;*
  - (D) the carrying out of other activities, such as those described in section 1118 of the ESEA.*

3. The **Harding Fine Arts Academy** will provide coordinate and integrate parental involvement strategies as other programs become available or are used by the school.
  
4. The **Harding Fine Arts Academy** will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). **HARDING FINE ARTS ACADEMY** will use the findings of the evaluation about its parental involvement policy and activities to design strategies for more effective parental involvement, and to revise, if necessary (and with the involvement of parents) its parental involvement policies. The evaluation will be conducted annually at the end of the summer program. The school administration will conduct the evaluation. Parents may give input at the meeting or through written response. The **Harding Fine Arts Academy** will build the schools' and parent's capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, through the following activities specifically described below:
  - A. **HARDING FINE ARTS ACADEMY** will provide assistance to parents of children served by **HARDING FINE ARTS ACADEMY**, as appropriate, in understanding topics such as the following:
    - the State's academic content standards,
    - the State's student academic achievement standards,
    - the State and local academic assessments including alternate assessments,
    - the requirements of Part A,
    - how to monitor their child's progress, and
    - how to work with educators.**HARDING FINE ARTS ACADEMY** will accomplish this through the following:
    - Dissemination of information produced by the state and edited by the school;
    - Web-based information;
    - Public and individual parent meetings (at parent convenience);
  
  - B. **HARDING FINE ARTS ACADEMY** will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by web-based resources, teacher generated notes, and inservice inclusion.

- C. **HARDING FINE ARTS ACADEMY** will educate its teachers, pupil services personnel, and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by utilizing appropriate inservice activities and parent/school meetings.
  
- D. **HARDING FINE ARTS ACADEMY** will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with outside agencies and other state sponsored programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children.
